Afghans carried out two suicide bombings in Pakistan, says Naqvi

 $Pakistans aid \, on Thursday \, Afghan \, nationals \, carried \,$ out two deadly suicide bombings in its territory this week, amid sharpening tensions between the South Asian neighbours over militant violence.

The involvement of Afghans in the attacks — one outside a courthouse in the capital on Tuesday, the other at a military school the day earlier - was "our major, serious concern," Interior Minister Mohsin Naqvi told parliament.

"We have traced the Islamabad blast culprits. The suicide bomber was from Afghanistan," he said, without offering any evidence. "It will be decided on a government-level what to do," the minister would proceed with regards to Afghanistan.

Nagyi repeated accusations that the Afghan Taliban administration was supporting militants who attacked Pakistan

The Afghan Taliban — which came to power in 2021 and has also accused Pakistan of backing Daesh-KP militants in its territory — denies that

Pakistani militants are present on its soil. A faction of the Pakistani Taliban claimed responsibility for the attack, the first to hit the

capital in nearly three years.

"We have also, on many occasions during operations against Daesh-KP, killed, neutralised, or captured Pakistani nationals," Afghan Taliban spokesperson Zabihullah Mujahid told Reuters

after the minister's televised speech. 'That does not mean the entire Pakistani nation behaves that way or that their government is responsible," Mujahid added.

Also on Friday, Pakistan categorically ruled out any possibility of negotiations with the Tehrik-e-Taliban Pakistan (TTP), the Balochistan Liberation Army (BLA) or any other terrorist groups, reiterat-

intensified under the Afghan Taliban regime. Addressing the weekly media briefing in Islamabad, the Foreign Office Spokesperson Tahir Hussain Andrabi said Pakistan supports dialogue with governments, but not with terror outfits. "Pakistan has never eschewed dialogue with any government in Kabul. However, Pakistan will not hold dialogue with any terrorist groups,

be it TTP or BLA," he said. A suicide bomber blew himself up close to a police patrol outside a lower court in Islamabad on Tuesday, killing 12 people and wounding 27.

Another bomber rammed an explosive-laden vehicle into the main gate of a military school in South Waziristan district, near the Afghan border, on Monday, killing three people.

Militants then entered the school, which is run by the military but educates civilians, triggering a $fight with {\tt Pakistanisol diersthat} continued for more$ than 24 hours until all of the attackers were killed.

The Pakistan army on Thursday escorted journalists from Islamabad to the Cadet College Wana, which showed clear signs of the assault.

said that all five attackers in the assault on the Cadet College Wana were killed by security forces. More than 600 people — including 525 cadets, their teachers and staff — were safely rescued, he told reporters.

Tarar said the assailants appeared to be attempting a repeat of the 2014 Peshawar school massacre, when a Tehrik-e-Taliban Pakistan (TTP) splinter group killed 154 people, mostly children, at an army-run school.

According to local media, authorities have arrested some suspects for questioning in connection with the Islamabad attack, and the detainees were captured in multiple raids.

Pakistan's Ministry of Information said the attack on the cadet college was planned and directed from Afghanistan and carried out by Afghan nationals using weapons supplied from there. In a post on X, the ministry said the assault was orchestrated by a militant identified only as Zahid, with approval from TTP's chief Noor Wali Mehsud.

Earlier, Defence Minister Khawaja Asif has ghanistan could not be ruled out after Tuesday's gruesome terrorism incidents in Islamabad and Khyber Pakhtunkhwa.

Asked during a TV interview if Pakistan would respond after these attacks and statements from the leadership linking them to Afghanistan, Asif said "God willing," adding that attacks on terrorist sanctuaries in Afghanistan "could not be ruled out" and could definitely happen.

ISLAMABAD: Justice Aminuddin Khan was on Friday sworn in as the first chief justice of the newly established Federal Constitutional Court (FCC) after the 27th Amendment was enacted

into law a day earlier. Meanwhile, President Zardari appointed six judges to the FCC. A notification issued by the law ministry said that the president made the appointments under Clause 3 of Article 175-A read with Article I75-C of the Constitution.

Justice Syed Hasan Azhar Rizvi, Justice Aamer Faroog and Justice Ali Bagar Najafi of the Supreme Court, Justice K.K. Agha of the Sindh High Court and Balochistan High Court Chief Justice Rozi Khan Barrech. Justice (retd) Arshad Hussain Shah has also been appointed as Supreme Court judge Justice Musarrat Hilali was not willing to join the FCC.

Chief of Army Staff (COAS) Field Marshal Asim Munirand Chairman Joint Chiefs of Staff Committee (CJCSC) General Sahir Shamshad Mirza were also
